Por fim, é disponibilizada uma plataforma acessível de consulta de doutrina jurídica, pensada para complementar a experiência de pesquisa no Jusbrasil, que inclui acesso ilimitado a um acervo com mais de 1200 obras, busca rápida e inteligente, sendo possível visualizar os capítulos relevantes para sua pesquisa logo abaixo da doutrina recomendada pelo buscador da plataforma, acesso a diversas obras do acervo já nas primeiras páginas da sua busca e cópia ilimitada de trechos dentro das obras já em formato ABNT.

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, GOSHME SOLUÇÕES PARA A INTERNET LTDA (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. ### **Getting paper copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. ### **Withdrawing your consent**
